DATE OF FINAL PASSAGE JUL 10 2015

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT THE 30TH STREET PIPELINE REPLACEMENT PROJECT IS STATUTORILY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT PURSUANT TO CEQA GUIDELINES SECTION 15262.

WHEREAS, the City of San Diego desires to execute an agreement with Rick Engineering Company for professional design consultant services for the 30th Street Pipeline Replacement project [Project]; and

WHEREAS, the California State Legislature, through the California Environmental Quality Act [CEQA], Public Resources Code sections 21000-21177, has determined that CEQA does not apply to various types of projects listed therein; and

WHEREAS, CEQA section 21084 states that the CEQA Guidelines shall list those classes of projects which have been determined not to have a significant effect on the environment and which shall be exempt from CEQA; and

WHEREAS, pursuant to that authority, CEQA Guideline sections 15260-15285 list the statutory exemptions promulgated by the California State Legislature; and

WHEREAS, after having considered the written record concerning the Agreement as well as public comment, if any, the Council of the City of San Diego (Council) has determined based upon its independent judgment that CEQA Guidelines section 15262 covers the Agreement;

NOW, THEREFORE,

BE IT RESOLVED, that the Project is statutorily exempt from CEQA pursuant to CEQA Guidelines section 15262.

BE IT FURTHER RESOLVED, that the City Clerk is directed to file a Notice of Exemption with the Clerk of the County of San Diego.
