A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING APPOINTMENTS TO THE
SAN DIEGO YOUTH COMMISSION

WHEREAS, San Diego Municipal Code sections 26.1601 to 26.1605 establish a City of San Diego Youth Commission (the Commission); and

WHEREAS, the Commission was created to serve as an advisory body to the Mayor, City Council, and City Manager on issues of interest to youth and pertaining to youth in the City of San Diego; and

WHEREAS, the Commission was created to facilitate the participation of youth and young adults in local government, as well as to provide City officials an opportunity to hear and address their ideas and concerns; and

WHEREAS, the Municipal Code states that the Commission will have 20 members, who shall serve two-year terms ending on July 1, and who shall serve until a successor is appointed and confirmed; and

WHEREAS, the Municipal Code requires the Mayor to appoint two members from each Councilmember's list of nominees, for a total of 18; and two additional members to be chosen by the Mayor; and


WHEREAS, the Mayor now seeks to fill vacancies on the board, and the appointments are subject to confirmation by a majority vote of the Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointments by the Mayor of the City of San Diego, to serve as members of the City of

San Diego Youth Commission, for the terms ending as indicated, are made and hereby confirmed:
