WHEREAS, the need for minor amendments to the General Plan, on file in the Office of the City Clerk as Document No. 309817 (General Plan Amendments), has been identified to ensure consistency with other adopted City documents and programs and to refine policies based on new information and implementation efforts; and

WHEREAS, the General Plan Amendments include edits to the Glossary and the Land Use and Community Planning, Mobility, Economic Prosperity, Public Facilities, Services and Safety, Recreation, and Noise Elements, as well as updates to the General Plan Land Use Map, Prime Industrial Lands Maps, and the Community Plan Designated Open Space and Parks Map; and

WHEREAS, on May 13, 2015, the Smart Growth and Land Use Committee of the City Council voted to forward the General Plan Amendments to the City Council without a recommendation; and

WHEREAS, on May 14, 2015, the Planning Commission of the City of San Diego voted to recommend approval of the General Plan Amendments; and

WHEREAS, on May 21, 2015, the Park and Recreation Board recommended approval of the General Plan Amendments; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego that the General Plan Amendments are adopted.
