A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AUTHORIZING THE MAYOR TO ENTER INTO  
AN AGREEMENT WITH SAN DIEGO SPORTS MEDICINE  
AND FAMILY HEALTH CENTER.

WHEREAS, the City released a request for proposals for the Fire-Rescue Department's Wellness Program in the Spring of 2015; and

WHEREAS, San Diego Sports Medicine and Family Health Center's (SDSM) proposal was selected as the winning proposal; and


WHEREAS, SDSM's proposal will continue to include all of the components of the Wellness Fitness Initiative designed by the International Association of Fire Chiefs and the International Association of Firefighters; and

WHEREAS, the initial compensation for the agreement with SDSM is \$1,135,882 for FY2016 as a General Fund expense; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor or his designee is authorized to enter into an agreement with the San Diego Sports Medicine and Family Health Center for the provision of Wellness Program services to the Fire-Rescue Department.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and to expend the funds for these services in the amount of \$1,135,882 for FY2016, and for each subsequent fiscal year as part of the adoption of the annual Appropriation Ordinance.
