A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING CAPITAL IMPROVEMENT PROGRAM FUND TRANSFERS BETWEEN SEVERAL CAPITAL IMPROVEMENT PROJECTS.

WHEREAS, on April 7, 2015, the Public Facilities Financing Authority (Authority) of the City of San Diego (City) issued its Lease Revenue Bonds Series 2015A and 2015B (Capital Improvement Projects)(CIP Bonds) to fund needed capital improvement projects within the City; and

WHEREAS, the CIP Bonds were delayed due to litigation for approximately a year and such delay has caused the need to reallocate bond proceeds to ensure that projects proceed as planned; and

WHEREAS, this action will transfer bond proceeds from the CIP Bonds among various Capital Improvement Projects as set forth below; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. The Chief Financial Officer is authorized to transfer appropriations of \$3,220,000 from CIP ABT.00001, City Facility Improvements to CIP AID.00005, Annual Allocation Streets within Fund 400860, PFFA Lease Revenue Bonds 2015B-Project; and
- 2. The Chief Financial Officer is authorized to transfer appropriations of \$1,780,000 from CIP S-00791, South Mission Beach Lifeguard Station, to CIP AID.00005, Annual Allocation Streets, within Fund 400860, PFFA Lease Revenue Bonds 2015B-Project; and
- 3. The Chief Financial Officer is authorized to transfer appropriations of \$1,710,255 from CIP A-CA.0001, Storm Drain Annual Allocation, of which \$1,631,255 is to CIP A-

CC.00001, Watershed CIP Annual Allocation, and \$79,000 is to S-11003 Coolidge Storm Drain within Fund 400860, PFFA Lease Revenue Bonds 2015BProject; and

- 4. The Chief Financial Officer is authorized to appropriate and expend up to \$120,000,000 in bond proceeds from Fund 400859, PFFA LEASE REVENUE BONDS 2015A-Project, in the amount of \$68,880,290; and from Fund 400860, PFFA LEASE REVENUE BONDS 2015B-Project, in the amount of \$51,119,710.
- 5. Nothing in this resolution shall constitute an approval of a project or a commitment to proceed with a project.
