A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING AN AMENDMENT TO COUNCIL POLICY NO. 100-18 ENTITLED "COMMUNITY PARKING DISTRICT."

WHEREAS, the City Council is charged with the responsibility of establishing policies to guide the various functions of the City, and where necessary, to establish procedures by which functions are performed; and

WHEREAS, on March 4, 1997, Council Policy No. 100-18 entitled "Parking Meter District Program" was adopted to allow formal advisory groups a mechanism for implementing solutions to parking issues in areas where parking meters were located; and

WHEREAS, on November 15, 2004, Council Policy 100-18 was amended to allow for the formation of parking districts that did not have parking meters within their boundaries but suffered with parking issues and as a reflection of this broader purpose renamed the program, "Community Parking District;" and

WHEREAS, on March 18, 2011, Council Policy 100-18 was further amended to refine the sharing of parking meter revenue between the City and Community Parking District funds and to authorize the formal advisory groups to analyze meter and on-street parking data and suggest recommendations on meter locations, rates, hours of operation, and new parking technology; and

WHEREAS, in late 2014 the Office of the City Auditor conducted a performance audit of the Community Parking District program and based on the findings of the audit made recommendations regarding management procedures, oversight, and accountability, and

WHEREAS, in a memorandum dated February 26, 2015 from Councilmember Gloria on

behalf of the Council Committee on Smart Growth and Land Use, a request was made for an

amendment to Council Policy No. 100-18 that provided more guidance and examples of eligible

uses of parking meter funds, established performance measures and year-end reporting, and

addressed long-term project planning; and

WHEREAS, the Council desires to amend Policy No. 100-18 in the manner

recommended by both the audit report and the Council Committee on Smart Growth and Land

Use; and

WHEREAS, the proposed amendments have been reviewed by the Council Committee

on Smart Growth and Land Use; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. Council Policy No. 100-18 entitled "Community Parking District" is amended as

set forth in the revised version of this Council Policy on file with the Office of the City Clerk as

2. The City Clerk is instructed to update the Council Policy Manual to include the

revised Council Policy No. 100-18.
