A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE DELEGATION OF AUTHORITY TO THE SAN DIEGO HOUSING COMMISSION, PURSUANT TO SAN DIEGO MUNICIPAL CODE SECTION 98.0301(D)(8), TO APPROVE THE SALE OF THE HOTEL METRO IN ACCORDANCE WITH HOTEL METRO REAL ESTATE DISPOSITION POLICY PO-RED-300.104, WITHOUT ADDITIONAL ACTION BY THE HOUSING AUTHORITY OF THE CITY OF SAN DIEGO.

WHEREAS, the San Diego Housing Commission is the owner of the real property located at 434 and 435 13th Street, in the City of San Diego, California; and

WHEREAS, in 1989 the Housing Commission leased the real property located at 434 and 435 13th Street to San Diego SRO Limited Partnership for 55 years; and

WHEREAS, San Diego SRO Limited Partnership has operated a 195-unit Single Room
Occupancy hotel at the property commonly known as the Hotel Metro since 1990; and

WHEREAS, the Hotel Metro is in a state of disrepair and neglect with extensive deferred maintenance to the mechanical, plumbing, and electrical systems and unit interiors; and

WHEREAS, the Housing Commission and the City of San Diego previously authorized replacement of the Hotel Metro with Alpha Square as described in Housing Authority Report HAR15-020 to preserve affordable housing in the City of San Diego and further the public policy of reducing homelessness and creating safe, decent and sanitary housing; and

WHEREAS, Alpha Square will be available for occupancy by low-income persons; and WHEREAS, on June 25, 2015, the Board of Commissioners of the Housing Commission recommended that the San Diego City Council approve implementation of the proposed project, as described herein and in Housing Authority Report HAR15-020; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that authority is delegated to the San Diego Housing Commission, pursuant to San Diego Municipal Code Section 98.0301(d)(8), to provide final approval of the sale of the Hotel Metro in accordance with Hotel Metro Real Estate Disposition Policy PO-RED-300.104, without additional action by the Housing Authority of the City of San Diego, unless any member of the Housing Authority requests to review the Housing Commission's approval within seven days of the date of such approval by the Housing Commission Board.
