A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING AND RATIFYING A SIDE LETTER AGREEMENT TO THE MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY AND THE AMERICAN FEDERATION OF STATE, COUNTY, AND MUNICIPAL EMPLOYEES, LOCAL 127 REGARDING TERMS AND CONDITIONS OF EMPLOYMENT FOR FISCAL YEARS 2015 THROUGH 2018.

WHEREAS, on October 1, 2013, the San Diego City Council (Council) adopted
San Diego Resolution R-308480 (Oct. 15, 2013), approving a Memorandum of Understanding
(MOU) between the City of San Diego and American Federation of State, County, and
Municipal Employees, Local 127 (Local 127), regarding terms and conditions of employment for
Fiscal Years 2014 through 2018; and

WHEREAS, the City and Local 127 have mutually agreed to amend paragraph D of Article 32 of the MOU to provide that, effective Fiscal Year 2017, the cash-in-waiver option for flex credits under the City's Flexible Benefits Plan (Plan) will be paid out semi-annually, rather than bi-weekly; and

WHEREAS, the semi-annual payments will be taxable income to the employees who receive them; and

WHEREAS, the City will make the first semi-annual payment on the pay day closest to, but before, December 24, 2016; and

WHEREAS, the City will make the second semi-annual payment on the second pay day in July 2017; and

WHEREAS, this Council action is to approve a Side Letter Agreement to the MOU, memorializing the agreement between the City and Local 127 and amending Article 32 of the

MOU; and

WHEREAS, under the Meyers-Milias-Brown Act (MMBA), the state law related to

collective bargaining between the City and its represented employees, and Council Policy

300-06, it is within the discretion of the Council to approve and ratify the negotiated agreement;

and

WHEREAS, the Council desires to approve and ratify the Side Letter Agreement, which

amends Article 32 of the MOU; NOW, THEREFORE,

BE IT RESOLVED that, under the authority of the MMBA and Council Policy 300-06,

the Council of the City of San Diego approves and ratifies the Side Letter Agreement to the

MOU between the City and Local 127, which amends Article 32 of the MOU related to the

payment of residual flex credits from the City's Flexible Benefits Plan, as specified in the Side

Letter Agreement on file in the Office of the City Clerk as Document No. R-309859.
