A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT BETWEEN MARK LLANO AND TAMMY DOMNGERN AND THE CITY OF SAN DIEGO

WHEREAS, on, filed a claim against the City of San Diego [City] alleging personal and property damages following a water main break outside their home on September 3, 2014; and

WHEREAS, in Closed Session on May 19, 2015, the City Council, by the following votes:

Yeas, Districts 1, 2, 3, 4, 5, 7 and 8; Nays, None; and absent, District 6, approved the Settlement.

WHEREAS, the City Council in closed session on May 19, 2015 authorized settlement of the Claim for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the Settlement Agreement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Council authorizes:

- 1. The sum of \$125,000 to be paid from the Water Utility Operating Fund 700011in settlement of each and every claim for damages, interest, costs and fees of any type, including attorney fees, against the City, its agents and employees, arising from the September 3, 2014 incident that is the subject of Mark Llano and Tammy Domngern's claim. The City has already advanced \$2,500.00 to claimants, thus the total outstanding settlement amount is \$125,000.
- 2. The Chief Financial Officer to appropriate and expend \$125,000 from the Water Utility Operating Fund 700011 in Fiscal Year 2016, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or

will be, on deposit with the City Treasurer, and contingent upon the adoption of the Annual Appropriation Ordinance.

- 3. The Comptroller to issue checks as follows:
- a. A check for the amount of One Hundred Thousand Dollars (\$100,000.00), made payable to Mark Anthony Llano and Tammy Domngern;
- b. A check for the amount of Twenty-Five Thousand Dollars (\$25,000.00) made payable to Aguirre & Severson LLP.
