3. The Chief Financial Officer is authorized to appropriate and expend MAD funds

for Fiscal Year 2016, including the management fund, district operating funds, district capital

funds, and developer deposit funds associated with new MAD formation activities for Fiscal

Year 2016 contingent upon approval of the Fiscal Year 2016 Appropriation Ordinance and

contingent upon the City Comptroller certifying that the funds necessary for expenditure are or

will be available.
