WHEREAS, there are no proposed increases to the assessments, other than those authorized at the time of formation, including increases based on the San Diego Consumer Price Index; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The updated Fiscal Year 2016 Engineer's Report, and the diagram located therein, for each of the City's self-managed MADs referenced above is hereby approved as filed.

2. The continued levy and collection of assessments on parcels within the self-managed MADs is hereby authorized for Fiscal Year 2016 to pay a prescribed portion of the costs of improvements and/or services as described in each updated Engineer's Report.

3. The Chief Financial Officer is authorized to appropriate and expend MAD funds for Fiscal Year 2016, including the management fund, district operating funds, district capital funds, and developer deposit funds associated with new MAD formation activities for Fiscal Year 2016 contingent upon approval of the Fiscal Year 2016 Appropriation Ordinance and contingent upon the City Comptroller certifying that the funds necessary for expenditure are or will be available.
