A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING ALL NECESSARY ACTIONS TO SECURE GRANT FUNDING FROM THE OFFICE OF HISTORIC PRESERVATION FOR THE COMPLETION OF A CITY-WIDE HISTORIC CONTEXT STATEMENT ADDRESSING THE THEMES AND RESOURCES SIGNIFICANT TO THE LESBIAN, GAY, BISEXUAL, TRANSGENDER AND QUEER COMMUNITY IN SAN DIEGO.

WHEREAS, the State of California, Office of Historic Preservation (OHP) has selected the City of San Diego to receive a 2015-2016 Certified Local Government (CLG) grant in the amount of \$30,000 to complete a City-wide historic context statement addressing the themes and resources significant to the Lesbian, Gay, Bisexual, Transgender and Queer (LGBTQ) community in San Diego (Historic Context Statement); and

WHEREAS, the proposed grant project focuses on developing themes and identifying resources significant to the City's rich and ethnically diverse LGBTQ history; and

WHEREAS, San Diego has a long association with the LGBTQ rights movement and is home to many advocacy and support groups; and

WHEREAS, the Historic Context Statement would guide future survey work and site-specific analysis and would provide a broad overview of the themes that have shaped the built environment, a narrative statement of significance for each theme, a discussion of the property types represented by the themes and their eligibility standards, preservation goals and policies, and a list of known designated and potential resources; and

WHEREAS, the CLG grant funds will be used to contract with a preservation planning professional meeting the Secretary of Interior's Professional Qualification Standards to assist

with public outreach, complete primary and secondary source research, conduct fieldwork and prepare the Historic Context Statement; NOW, THEREFORE,


BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor or his representative is authorized to make an application to the State of California, Office of Historic Preservation, and to take all necessary actions to secure grant funding for an amount of up to \$30,000 in CLG funds to prepare the Historic Context Statement addressing LGBTQ history and resources in San Diego.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to accept up to \$30,000 of awarded grant funding from the State Office of Historic Preservation.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to establish a special interest-bearing fund for the grant funding, if required.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend, up to \$30,000 of the State Office of Historic Preservation Grant allocations, contingent upon receipt of a fully executed grant agreement.
