A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO MAKING CERTAIN DETERMINATIONS RELATED TO THE RELOCATION PLAN FOR THE MAYBERRY TOWNHOMES AFFORDABLE HOUSING REHABILITATION PROJECT.

WHEREAS, Civic San Diego negotiated on behalf of the City, and the City Council approved on March 10, 2015, a Loan Modification Agreement (LMA) with Mountain View Housing Associates, LP (Mountain View) pertaining to the substantial rehabilitation of the 70-unit Mayberry Townhomes affordable housing project (Project) located at 4328-4490 Mayberry Street in the Southcrest community of the City of San Diego (Property); and

WHEREAS, Mountain View has caused a qualified relocation consultant, Laurin Associates, a Division of Raney Planning and Management, Inc. (Relocation Consultant), to prepare that certain February 2015 Mayberry Townhomes Relocation Plan for the Project (Relocation Plan), included as Attachment A to Staff Report No. CSD-15-04 accompanying this Resolution; and

WHEREAS, the Relocation Plan constitutes a feasible method or plan for any temporary relocation during the rehabilitation work contemplated under the LMA and for relocation of the eligible over-income residents (earning incomes above the income restrictions provided for in the LMA) to be permanently displaced as a result of the Project, in accordance with applicable relocation laws and regulations; and

WHEREAS, Mountain View and the Relocation Consultant will be responsible for implementing all actions contemplated by the Relocation Plan and fulfilling all requirements under applicable relocation laws and regulations; and

WHEREAS, California Code of Regulations, Title 25, section 6010 states that no public entity may proceed with any phase of a project or other activity that will result in displacement of any person, business, or farm until the public entity makes certain determinations; and

WHEREAS, in accordance with California Code of Regulations, Title 25, section 6010, the Council will make the following determinations with respect to the Relocation Plan (collectively, the Relocation Determinations) through adoption of this Resolution:

(1) Fair and reasonable relocation payments will be provided to eligible persons as required by Article 3 of Title 25, Division 1, Chapter 6, Subchapter 1 of the California Code of Regulations (Relocation Guidelines);

(2) A relocation assistance program offering the services described in Article 2 of the Relocation Guidelines will be established;

(3) Eligible persons will be adequately informed of the assistance, benefits, policies, practices and procedures, including grievance procedures, specified in the Relocation Guidelines;

(4) Based upon recent survey and analysis of both the relocation needs of persons who will be displaced and available replacement locations and considering competing demands for those locations, comparable replacement locations will be available, or provided, if necessary, within a reasonable period of time prior to displacement sufficient in number, size, and cost for the eligible persons who require them;

(5) Adequate provisions have been made to provide orderly, timely, and efficient relocation of eligible persons to comparable replacement locations without regard to race, color, religion, sex, marital status, or national origin with minimum hardship to those affected; and

(6) The Relocation Plan meets the requirements of California Code of Regulations, Title 25, section 6038; and

WHEREAS, the Relocation Consultant has estimated that the total cost of relocation assistance and benefits to be provided under the Relocation Plan is \$382,500; and

WHEREAS, written notice of the Relocation Plan was provided to all current occupants of the Property at least thirty (30) days before the Council's consideration and approval of the Relocation Plan in accordance with California Code of Regulations, Title 25, section 6038;

NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:

1. The Council finds and determines that all recitals set forth in this Resolution are true and correct and fully incorporated herein by this reference, and specifically makes the Relocation Determinations set forth in this Resolution.

2. The Council approves the Relocation Plan, a copy of which shall be placed on file with the City Clerk as Document No. RR- 309895.
