A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN INCREASE IN THE TASK ORDER AMOUNT FOR THE MULTIPLE AWARD CONSTRUCTION CONTRACT TASK #10 FOR WATER AND SEWER GROUP JOB 816.

WHEREAS, on October 23, 2012, the Council of the City of San Diego [Council] authorized the Mayor or his designee to execute multiple design-build contracts with five design-build entities, in which the design-build entities compete for public works projects on a task order basis pursuant to San Diego Municipal Code section 22.3310 (Resolution R-307739); and WHEREAS, the design-build firms approved by the Council are as follows:

- Orion Construction Corp. / Balboa Construction, Inc. in association with Harris & Associates and Richard Brady & Associates (Document No. RR-307739-1);
- El Cajon Grading & Engineering Company, Inc. in association with David Evans
   & Associates, Inc. (Document No. RR-307739-2);
- 3. J.R Filanc Construction Company, Inc. in association with Arrieta Construction,
  Inc. and HDR. (Documents No. RR-307739-3);
- 4. Ortiz Corporation in association with AECOM. (Document No. RR-307739-4); and
- 5. TC Construction Company in Association with RBF Consulting. (Document No. RR-307739-5).

WHEREAS, San Diego Municipal Code section 22.3310(f) authorizes task orders in an amount not to exceed \$10,000,000 without City Council approval; and

WHEREAS, an increase in the task order amounts will accelerate construction of sewer and water main projects in an area known for pipeline deterioration, and will improve sewer and water services in the community; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor or his designee is authorized, for and on behalf of the City, to increase a task order to an amount not to exceed \$20,000,000 for the selected design-build firm T.C. Construction, Inc. for Water and Sewer Group 816 [Project], contingent upon the City Comptroller's first certifying that the funds are, or will be on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the use of City Force Work, Water Fund 700010, CIP S-13015, Water Utility CIP, Water and Sewer Group 816 (W) in an amount not to exceed \$1,910,000 is authorized for the purpose of the Project and related expenses, contingent upon the City Comptroller's first certifying that the funds are, or will be on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the use of City Force Work from Sewer in Fund 700008, CIP A-JA.00001, Annual Allocation – Sewer Main Replacements (B-00443) Muni Sewer CIP in an amount not to exceed \$140,000 is authorized for the purpose of the Project and related expenses, contingent upon the City Comptroller's first certifying that the funds are, or will be on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the Chief Financial Officer as delegated to Financial Management is authorized to appropriate and the City Comptroller is authorized to expend an amount not to exceed \$20,000,000 to fund task orders to the selected firm for the awarded design-build contract with three years in duration upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year, and contingent upon the City Comptroller first finishing
