A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO ADOPTING THE MITIGATION, MONITORING
AND REPORTING PROGRAM FOR WATER AND SEWER
GROUP JOB 816.

WHEREAS, the City of San Diego [City] seeks to award a Multiple Award Construction Contract (MACC) to be utilized for implementation of the City's Capital Improvement Projects (R-307739); and

BE IT RESOLVED, by the Council of the City of San Diego [Council], that the Addendum to Mitigated Negative Declaration No. 255100, Project No. 352788, dated July 16, 2014 [Addendum to MND] for Water and Sewer Group Job 816 [Project] on file in the Office of the City Clerk, has been completed in compliance with the California Environmental Quality Act of 1970 (California Public Resources Code section 21000 *et seq.*), as amended, and the State guidelines thereto (California Code of Regulations sections 15000 *et seq.*).


BE IT FURTHER RESOLVED, that the Addendum to MND reflects the independent judgment of the City of San Diego as Lead Agency and that the information contained in the report, together with any comments received during the public review process, has been reviewed and considered by this Council in connection with the approval of the Project.

BE IT FURTHER RESOLVED, that the Council finds that revisions to the Project now mitigate potentially significant effects on the environment previously identified in the Initial Study and therefore, that said Addendum to MND No. 255100, Project No. 352788, a copy of which is on file in the Office of the City Clerk and incorporated herein by this reference, is approved.

BE IT FURTHER RESOLVED, that pursuant to California Public Resources Code section 21081.6, the Council hereby adopts the Mitigation Monitoring and Reporting Program, or alterations to implement the changes to the Project as required by this body in order to mitigate or avoid significant effects on the environment, a copy of which is attached hereto and incorporated herein by this reference

BE IT FURTHER RESOLVED, that the City Clerk is directed to file a Notice of Determination [NOD] with the Clerk of the Board of Supervisors for the County of San Diego regarding the Project.
