A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN AGREEMENT WITH SCS ENGINEERS FOR LANDFILL GAS COLLECTION SYSTEM MAINTENANCE FOR THE ARIZONA STREET AND SOUTH CHOLLAS LANDFILLS.

WHEREAS, the Environmental Services Department requires the services of an environmental engineering consultant firm to support the City's compliance with local, state and federal regulations applicable to the landfill gas collection systems at the City's Arizona Street and South Chollas Landfills, and to optimize landfill gas collection efficiency at those sites; and

WHEREAS, in conformance with Council Policy 300-07 and Administrative Regulation 25.60, the City advertised a Request for Proposals for environmental engineering services related to landfill gas collection system maintenance for the Arizona Street and South Chollas Landfills (the Services); and

WHEREAS, SCS Engineers was selected as the most highly qualified firm to provide the Services, subject to Council approval; and

WHEREAS, the Environment Committee heard this item on July 15, 2015, and recommended that the City Council approve the contract award to SCS Engineers; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, an agreement with SCS Engineers for environmental engineering services related to landfill gas collection system maintenance for the Arizona Street and South Chollas Landfills, in an

amount not to exceed \$500,000, under the terms and conditions set forth in the Agreement on file with the City Clerk as Document No. RR- 309925.

2. That the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$500,000 from Refuse Disposal Fund No. 700039, solely and exclusively to provide funds for the Agreement, contingent upon Council approval of the annual Appropriations Ordinance for the applicable fiscal year and upon the Chief Financial Officer first furnishing one or more certificates demonstrating funds are, or will be, on deposit with the City Treasurer.
