WHEREAS, on June 24, 2010, the Planning Commission approved an initiation to consider amendments to several community plans to adopt the Carmel Mountain/Del Mar Mesa Preserves Natural Resources Management Plan (NRMP); and

WHEREAS, acting on that initiation, the City desires to adopt the Carmel Mountain/Del Mar Mesa Preserves NRMP; and

WHEREAS, the NRMP would provide guidance for the present and future use and maintenance of Carmel Mountain Open Space Preserve and Del Mar Mesa Open Space Preserve, as well as "Area Specific Management Directives" which satisfy requirements of the City's Multiple Species Conservation Program's (MSCP) Implementing Agreement for these areas; and

WHEREAS, the NRMP is intended to make provisions for the protection and preservation of the natural resources, as well as to allow safe and accessible use of the Park and to meet the needs of the present and future communities through the trail plan; and

WHEREAS, the NRMP provides for maintenance of the quality of the Park's natural environment and associated visual enjoyment of the Park's open space. The NRMP may be amended as needed to complement any future Park Master Plan or new management directives within the NRMP area; and

WHEREAS, the NRMP would benefit the community by enhancing recreational opportunities through the addition of multi-use trails and increased access to the park system; and

WHEREAS, the proposed NRMP would result in the consolidation of trail alignments into existing built trails that connect Deer Canyon to the Del Mar Mesa Preserve; and

WHEREAS, the closure of illicitly built trails as a result of this process will enhance the preservation and protection of sensitive biological and cultural resources within the Park; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Carmel Mountain/Del Mar Mesa Preserves Natural Resource Management Plan is approved, and a copy of which is on file in the office of the City Clerk as Document No. RR- 309952.
