DATE OF FINAL PASSAGE SEP 24 2015

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING INCREASES TO THE CITY'S
LOBBYIST REGISTRATION FEES.

WHEREAS, it is the policy of the City of San Diego to establish fees to recover the costs of providing services in accordance with the City of San Diego Administrative Regulation 95.25; and

WHEREAS, San Diego Ordinance O-19656, adopted Aug. 3, 2007 provides for the listing of Council approved lobbyist registration fees to be filed in the City Official Rate Book; and

WHEREAS, Municipal Code section 27.4010 provides that the City Clerk shall from time to time recommend fee amounts to the Council that reflect, but do not exceed, the City's costs of administering the lobbyist filing requirements; and

WHEREAS, the lobbyist registration fees have not been increased since November 8, 2007 (San Diego Resolution R-303107 (Nov. 8, 2007)), and do not reflect the current cost to the City to administer the program; and

WHEREAS, the City Clerk conducted an extensive cost of service study (COSS), using conservative estimates to ensure fees did not exceed the cost of service; and

WHEREAS, on July 15, 2015, the City Clerk requested the Budget and Finance Committee recommend City Council approval of an increase in City lobbyist registration fees to the following amounts (Proposed New Fees):

Annual Lobbyist Registration:	\$150.00
Pro-rated Registration after October 1:	\$60.00

Annual Client Registration: \$30.00

Pro-rated Client Registration after October 1: \$12.00

and;

WHEREAS, the proposed fees are justified by the COSS; and


WHEREAS, on July 15, 2015, the Budget and Finance Committee voted 5-0 to recommend Council approval of the update the City lobbyist registration fees as requested;

NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council approves the Proposed New Fees for lobbyist registration, effective January 1, 2016.

BE IT FURTHER RESOLVED, that the City Clerk is directed to place the updated lobbyist registration fees in the City Rate Book.
