WHEREAS, the City Auditor issued the Performance Audit of the San Diego Fire-Rescue Department, Lifeguard Division (Audit) in May 2015; and

WHEREAS, the Audit was heard at the Audit Committee meeting on June 3, 2015, where the unanimous vote was to accept the Audit and forward it to be heard by the City Council with direction to the Lifeguard's Division to report back to the Audit Committee in November with a follow-up; and

WHEREAS, the Audit was on the City Council agenda for July 27, 2015, as Item No. 151 and was noticed as an informational item only; and


WHEREAS, on July 27, 2015, the City Council heard the findings and recommendations of the City Auditor related to the Audit; and

WHEREAS, the City Council did not have the opportunity to vote to receive and accept the Audit because it was noticed as an informational item only; and

WHEREAS, the Audit is now being re-docketed so that the City Council may vote to receive and accept the Audit; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Performance Audit of the San Diego Fire-Rescue Department, Lifeguard Services Division is received and accepted by the City Council.


