WHEREAS, the Municipal Code also requires that the City Council approve by resolution any new Records Disposition Schedule, or any amendment to an existing Records Disposition Schedule, for a City department, board or commission; and

WHEREAS, the Municipal Code provides that the City Attorney or designee, and the City Clerk's Office must first approve a Records Disposition Schedule or any amendments to the schedule, ensuring that the schedule complies with laws related to the retention and disposition of public records; and

WHEREAS, the Purchasing & Contracting Department now seeks Council confirmation of a Records Disposition Schedule for its Living Wage Program, and the schedule has been approved by the City Attorney's Office and the City Clerk's Office; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Records

Disposition Schedule for the Purchasing & Contracting Department – Living Wage Program, on file with the Office of the City Clerk, is hereby approved.
