WHEREAS, in Closed Session on July 13, 2015, the City Council, by the following votes: Yeas, District(s) 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, District(s) None, approved the Settlement Agreement.

WHEREAS, the City Council in closed session on July 13, 2015 authorized settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the Settlement Agreement;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of San Diego that the Council authorizes:

1. The sum of \$300,000 to be paid from the Public Liability Fund, Fund No. 720045, in settlement of each and every claim for damages, interest, costs and fees of any type, including attorney fees, against the City, its agents and employees, arising from the Litigation.

- 2. The Comptroller to issue a check in the amount of \$300,000 payable to Kathryn
- B. Meadows Client Trust Account fbo Marjorie Helm.
