WHEREAS, in Closed Session on July 13, 2015, the City Council, by the following votes: Yeas, District(s) 1, 2, 3, 4, 5, 6, 7, 8; Nays, District(s) None; (District(s) 1, 2, 3, 4, 5, 6, 7, 8, All Present, approved the Settlement.

WHEREAS, the City Council in closed session on July 13, 2015 authorized settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the Settlement Agreement; NOW, THEREFORE,

BE IT RESOLVED, that the Council of the City of San Diego authorizes:

1. The Mayor or his designee to pay the sum of \$192,500.00 from the Water Utility

Operating Fund 700011, in settlement of each and every claim for damages, interest, costs, and

fees of any type, including attorney fees, against City, its agents and employees, arising from the

property damage claim of the Litigation;

- 2. The Chief Financial Officer expend \$192,500.00 from Water Utility Operating Fund 700011, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer;
- 3. The Comptroller to issue a check in the amount of \$192,500.00, made payable to Bauman Loewe Witt & Maxwell Trust Account.
