A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE ACCEPTANCE AND EXPENDITURE OF \$16,600 IN GRANT FUNDS FROM THE CALIFORNIA HEALTHCARE FOUNDATION FOR DATA COLLECTION PERTAINING TO THE CITY'S COMMUNITY PARAMEDICINE PROGRAM.

WHEREAS, the City's Fire-Rescue Department is taking part in the Community

Paramedicine Program sponsored by the State of California Emergency Medical Services

Authority; and

WHEREAS, this program is a pilot program meant to test different ways paramedics can positively impact health care in a pre-hospital setting; and

WHEREAS, in support of this program, the California HealthCare Foundation is providing the City a grant to cover the cost of data collection; and

WHEREAS, data collected through this program will be sent to the University of California, San Francisco for analysis; and

WHEREAS, the amount of grant money awarded to the City is \$16,600; and

WHEREAS, the City plans on using these funds to customize the electronic patient care record software it currently uses so that the data for the Community Paramedicine Program can be collected; and

WHEREAS, all expenses related to these grant funds will incur to Fund 600002 Grant 1000442-2015; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor or his designee is authorized to accept and take all necessary actions to secure a \$16,600 grant stipend

from the California HealthCare Foundation for data collection pertaining to the City's participation in the Community Paramedicine Program.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate, and expend an amount not to exceed \$16,600 from Fund 600002

Grant 1000442-2015 contingent upon receiving a fully executed grant agreement.

BE IT FURTHER RESOLVED, that the Chief Operating Office is authorized to set up a special interest bearing account for these grant funds, if required.
