DATE OF FINAL PASSAGE SEP 29 2015

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPOINTING BRIAN FENNESSY TO THE
POSITION OF CHIEF OF THE SAN DIEGO FIRE-RESCUE
DEPARTMENT.

WHEREAS, Charter section 58 provides that the Chief of the Fire Department shall be appointed by the City Manager and the appointment shall be confirmed by a majority of the Council; and

WHEREAS, Charter section 260(b) provides that all executive authority, power, and responsibilities conferred upon the City Manager in Article V, including Charter section 58, shall be transferred to, assumed, and carried out by the Mayor during the time period under which the City operates as a Mayor-Council form of government; and


WHEREAS, Chief Javier Mainar will retire from the position as Chief of the San Diego Fire-Rescue Department on November 12, 2015 at 5:00 p.m. resulting in a vacancy in the position; and

WHEREAS, Brian Fennessy is a 38-year veteran in fire service; he began his fire service as a U.S. Forest Service and Bureau of Land Management wildland firefighter; in 1990 he was hired by the City of San Diego where he quickly promoted through each rank of the Fire-Rescue Department, from firefighter, to engineer, Captain, Chief of Air Operations, Deputy Chief and Assistant Fire Chief.

WHEREAS, the Mayor has appointed Brian Fennessy to the position of Chief of the San Diego Fire-Rescue Department, subject to Council confirmation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council hereby confirms the appointment of Brian Fennessy to be Chief of the San Diego Fire-Rescue Department of the City of San Diego, effective November 12, 2015 at 5:01 p.m.


