A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTION OF AND EXPENDITURES FOR AN AGREEMENT WITH ACCELA, INC. FOR THE REPLACEMENT OF THE DEVELOPMENT SERVICES DEPARTMENT PROJECT TRACKING SYSTEM AND RELATED SERVICES FOR FIVE YEARS.

WHEREAS, the City of San Diego Development Services Department (DSD) utilizes the current Project Tracking System (PTS) to process hundreds of thousands of permits, inspections, and other transactions and inquiries; and

WHEREAS, PTS is 15 years old and no longer meets the needs of needs of the City; audits have identified various concerns relating to security and long-term viability; and

WHEREAS, Accela, Inc. has contracts with local and state public agencies, as well as with public agencies nationwide and is the market leader; and

WHEREAS, the processing and customer service options available through Accela will allow for improvements over the current processing and will be used to provide, implement, and maintain a new information system, manage the customer flow in the lobby, project review, fee calculation and cashiering, permit issuance, construction inspection, and code enforcement workflows in the City's land development process; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:

1. That the Mayor or his designee is authorized to execute the Agreement with Accela, Inc., including the Software License Agreement (Exhibit 2), on file in the Office of the City Clerk as document number RR- 309996.

2. That the Chief Financial Officer is authorized to expend amounts not to exceed \$7,043,291.28 in the first year of the contract term, and \$966,920.60 in each subsequent year of

the contract term, for a total expenditure not to exceed \$10,910,973.68, contingent upon the City Council approval of the given year Appropriation Ordinance and the City Comptroller furnishing one or more certificates demonstrating that funds necessary for the expenditure are, or will be, on deposit with the City Treasurer.
