BE IT RESOLVED, that the Chief Financial Officer is hereby authorized to appropriate and expend \$77,195.00 from the Public Liability Fund No. 720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the City Comptroller is hereby authorized to issue a check in the amount of \$77,195.00, made payable to the Law Office of Michael A. Conger Client Trust Account, in full and final settlement of all of Steven L. Perkins' employment discrimination claims against the City of San Diego, its agents and employees.
