A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTION OF A THIRD AMENDMENT WITH MALLORY SAFETY AND SUPPLY, LLC FOR THE PROVISION SPECIALIZED PUBLIC SAFETY EQUIPMENT.

WHEREAS, in February of 2012, the City of San Diego Office of Homeland Security entered into a Contract with Mallory Safety and Supply, LLC (Mallory) for use of U.S. Communities Contract No. 440001839; and

WHEREAS, this Contract with Mallory allows the City to procure specialized public safety equipment in an expedited manner that complies with all relevant grant requirements, provides efficient delivery of products, and obtains the best value for the City; and

WHEREAS, the City wishes execute a Third Amendment to the Contract with Mallory in order to extend the Contract with Mallory for an additional year, and seeks Council approval for additional expenditures not to exceed \$2,500,000 throughout this extension; and

WHEREAS, this Third Amendment does not obligate the City to procure goods and services; and


WHEREAS, expenditures under this Contract will incur within the approved sponsorship programs per executed grant agreements, Fund 600000 (Grant Fund-Federal) and then will be reimbursed from the corresponding federal grant programs; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor, or his designee, is authorized to execute, for and on behalf of the City, a Third Amendment with Mallory Safety and Supply, LLC., for the use of U.S. Communities Contract No. 440001839 for

an additional year, to provide procurement of specialized safety, emergency preparedness supplies, and related grant equipment.

BE IT FURTHER RESOLVED, that the Chief Financial Officer, or his designee, is authorized to expend an amount not to exceed \$2,500,000 in Fiscal Year 2016 for the purpose of executing the as needed Third Amendment with Mallory Safety and Supply, LLC contingent upon grant funding being secured by executed grant agreements or non-grant funding being certified by the Chief Financial Officer for availability.
