BE IT RESOLVED, by the Council of the City of San Diego, that in accordance with San Diego Municipal Code section 82.19, the conversion of the alley north of K Street between 31st Street and 32nd Street to a one-way eastbound operation is authorized.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$800 from Fund 100000 – General Fund, Transportation & Storm Water Department – Street Division's operating budget, for the installation of the necessary signs

and pavement markings to convert the alley to a one-way operation.
