DATE OF FINAL PASSAGE NOV 20 2015

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO TO AUTHORIZE THE CONVERSION OF AN
ALLEY NORTH OF K STREET BETWEEN 31ST STREET AND
32ND STREET TO A ONE-WAY EASTBOUND OPERATION.

WHEREAS, residents of K Street have expressed concern about the traffic flow in the
alley north of K Street between 31st Street and 32nd Street; and

WHEREAS, a petition to convert the alley to one-way operation was signed with 85% of
residents in favor; and

WHEREAS, the Southeastern San Diego Planning Group voted 9-0 in support of the
requested change; and


WHEREAS, converting the alleys to one-way operations will provide a more orderly
flow of traffic and reduce congestion; NOW, THEREFORE

BE IT RESOLVED, by the Council of the City of San Diego, that in accordance with
San Diego Municipal Code section 82.19, the conversion of the alley north of K Street between
31st Street and 32nd Street to a one-way eastbound operation is authorized.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend
an amount not to exceed \$800 from Fund 100000 – General Fund, Transportation & Storm
Water Department – Street Division’s operating budget, for the installation of the necessary signs


and pavement markings to convert the alley to a one-way operation.
