A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING CALIFORNIA COASTAL COMMISSION SUGGESTED MODIFICATIONS TO THE OCEAN BEACH COMMUNITY PLAN AND LOCAL COASTAL PROGRAM AND ADOPTING AMENDMENTS TO THE OCEAN BEACH COMMUNITY PLAN AND LOCAL COASTAL PROGRAM.

WHEREAS, on July 29, 2014, the City Council of the City of San Diego held a public hearing for the purpose of considering amendments to the Ocean Beach Community Plan, the General Plan and Implementation Plan, and other actions associated with the comprehensive update to the 1975 Ocean Beach Community Plan and Local Coastal Program; and

WHEREAS, on July 29, 2014, the City Council of the City of San Diego adopted and recommended certification to the California Coastal Commission of the July 2014 Ocean Beach Community Plan and Local Coastal Program update; and

WHEREAS, the California Coastal Act (Public Resources Code section 30000 et seq.) requires California Coastal Commission certification of a land use plan of a proposed local coastal program; and

WHEREAS, on August 13, 2015, the California Coastal Commission approved the July 2014 Ocean Beach Community Plan and Local Coastal Program update with suggested modifications that address lower cost visitor serving accommodations, environmentally sensitive habitat areas, water quality, public access and recreation, sea level rise, and shoreline development; and

WHEREAS, on September 22, 2015, the California Coastal Commission transmitted, in writing, to the City of San Diego, the suggested modifications for adoption by the Council of the City of San Diego; and

WHEREAS, on November 9, 2015, the City Council considered the California Coastal Commission suggested modifications and the de minimis revisions identified by City staff;

NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:

1. That this City Council approves the California Coastal Commission suggested modifications to the Council-adopted July 2014 Ocean Beach Community Plan and Local Coastal Program.

2. That the City Council adopts amendments to the Ocean Beach Community Plan and Local Coastal Program that implement the comprehensive update thereto, and that it adopts corresponding amendments to the General Plan, with a copy of said update being on file in the office of the City Clerk as Document No. RR - 310057.

3. That after adoption, the Mayor or his designee is authorized to submit this resolution to the California Coastal Commission for final certification and incorporation into the City's certified Local Coastal Program.

BE IT FURTHER RESOLVED, that this resolution shall not take effect until the date the California Coastal Commission unconditionally certifies these provisions as a local coastal program amendment.




