WHEREAS, in May 1999, the City of San Diego (City) expended \$258,000 in Community Development Block Grant (CDBG) funds to the George G. Glenner Alzheimer's Family Center, Inc., a 501(c)(3) non-profit corporation (Glenner), regarding the acquisition of property at 3702 Fourth Avenue (Property) pursuant to an agreement included as Attachment 1 to this Staff Report accompanying this Resolution (Glenner Agreement); and

WHEREAS, on July 24, 2015, Glenner informed the City of its intention to sell the Property; and

WHEREAS, the Glenner Agreement includes a formula to determine the repayment of CDBG funds owed to the City upon sale or transfer of the Property; and

WHEREAS, Glenner has requested a revision to the formula that allows the City to receive full repayment of the original \$258,000 in CDBG funds, plus a return on the City's investment, and also provides Glenner with the ability to recoup costs for improvements made to the Property; and

WHEREAS, the City desires to amend the Glenner Agreement to address revisions in the formula for the calculation of the repayment to the City pursuant to an agreement included as Attachment 2 to the Staff Report (First Amendment); NOW, THEREFORE,
