DATE OF FINAL PASSAGE NOV 16 2015

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
SAN DIEGO TEMPORARILY CHANGING RULE 4.2 OF THE  
PERMANENT RULES OF COUNCIL RELATING TO THE  
SELECTION OF THE COUNCIL PRESIDENT.

WHEREAS, Rule 9 of the Permanent Rules of Council provides that the Council President may, at any time, place on the Adoption Agenda a resolution establishing a temporary rule that shall supersede a Permanent Rule for the time period as may be specified in the temporary rule; and

WHEREAS, on June 3, 2014, voters of the City of San Diego approved Proposition A, which amended the San Diego Charter to change an elected officer's term of office from the "first Monday after the first day of December next succeeding their election" to the "tenth day of December"; and

WHEREAS, Rule 4.2 was amended to ensure selection of a Council President after Councilmembers have been elected to new terms; and

WHEREAS, in order to provide for additional time for Council Administration and appointments at the end of the calendar year, the Council President proposes a temporary rule to allow for the selection of a Council President in non-election years to occur at the first Monday meeting held in December; and

WHEREAS, the Charter Review Committee has recommended an amendment to the Permanent Rules to select the Council President in non-election years at the first Monday Council meeting in December, which amendments are pending Council approval; and

WHEREAS, a temporary rule is necessary to allow for the Council President selection to occur prior to December 10 in this non-election year; and


WHEREAS, under Charter section 280(a)(1) this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the City Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following temporary rule shall apply and supersede Rule 4.2 of the Permanent Rules of Council until an ordinance amending Rule 4.2 is effective or rejected:

**4.2 Selection of the President**

In odd-numbered years, at the first Monday Council meeting in December, and in even-numbered years, at the first Council meeting held on or after the tenth day of December, the Council shall select a Council President from one of its members by majority vote of the Council. The Council President shall serve for a term of one year, commencing on the date set forth above, or until a successor is selected and qualified, whichever is later. The Council President may serve more than one term.
