A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING EXECUTION OF A
MAINTENANCE AGREEMENT WITH CITY HEIGHTS TOWN
COUNCIL FOR THE EUCLID AVENUE GATEWAY
IMPROVEMENTS PROJECT.

WHEREAS, the Euclid Avenue Gateway, CIP 52-699.0 project, located at the northeast corner of Home Avenue and Euclid Avenue in the neighborhood of City Heights, was constructed in 2005 without the landscaping component that was part of the original plans; and

WHEREAS, the landscaping component was removed because funding for maintenance of the landscaping had not been identified; and

WHEREAS, the City Heights Town Council is willing to assume the responsibilities and expense for maintaining the landscape improvements and enter into a maintenance agreement with the City, thus allowing for installation of the landscaping; NOW, THEREFORE,

BE IT RESOLVED, that the Mayor, or his designee, is authorized to execute an agreement with the City Heights Town Council, a nonprofit corporation, whereby the Town Council will undertake the maintenance obligations for the landscape elements of the Euclid Avenue Improvements, CIP S-00886, project at its sole expense, a copy of which agreement is on file with the Office of the City Clerk as document number RR- 310081.


