A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO APPROVE ADJUSTMENTS TO RECYCLED WATER RATES, ACCEPT THE RECYCLED WATER PRICING STUDY AND TAKE ASSOCIATED ACTIONS.

WHEREAS, the City of San Diego (City) owns and operates a recycled water system that provides recycled water to customers within a population of over 1.4 million via the North City Water Reclamation Plant and the South Bay Water Reclamation Plant; and

WHEREAS, for recycled water rates, a Peer Review of the 2013 Recycled Water Pricing Study (Pricing Study) Report has been completed by Black & Veatch consultants; and

WHEREAS, the City currently sells recycled water at a commodity rate of \$0.80/HCF, and the proposed unitary rate increase to \$1.73/HCF recommended by the Department in the Pricing Study will align and distribute current costs, benefiting all rate payers, while providing an incentive for the use of recycled water; and

WHEREAS, in accordance with Article XIID, section 6 of the California Constitution (Proposition 218), the City noticed a public hearing for November 17, 2015 and mailed a Notice of the proposed water rate adjustments to all City water customers, a copy of which Notice is on file with the City Clerk as Document No. RR-310097; and

WHEREAS, the Proposition 218 Notice was mailed at least 45 days prior to the noticed public hearing, and the City did not receive written protests from a majority of the affected water customers by the close of the public hearing conducted in accordance with Proposition 218 and the procedures previously adopted by the Council in Resolution No. R-302245; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego:

1. That the Recycled Water Pricing Study and the Peer Review Memorandum are accepted and the Department recommended Unitary recycled water base fee and commodity charge adjustments are authorized, consistent with the revised Recycled Water Pricing Study per the Peer Review Memorandum.
