

RESOLUTION NUMBER R- 310101

DATE OF FINAL PASSAGE DEC 07 2015

A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO SELECTING A COUNCIL PRESIDENT.

WHEREAS, San Diego Charter (Charter) section 270(d) provides that the San Diego City Council (Council) shall have the right to determine its own rules and order of business, including a process for the selection of a presiding officer to chair Council meetings and manage the docket process; and

WHEREAS, Rule 4.2 of the Rules of the City Council, San Diego Municipal Code section 22.0101, provides that the Council shall, at the first regular Council meeting held after 10:00 a.m. the first Monday after the first day of December, select a President from one of its members by majority vote, to serve for a term of one year or until a successor is selected and qualified, whichever is later; and


WHEREAS, on November 16, 2015, the Council, by San Diego Resolution R-310076, adopted a temporary rule providing for the selection of the Council President at the first Monday meeting in December in odd-numbered years; and

WHEREAS, it is now necessary for the Council to select one of its members to serve as Council President; and

WHEREAS, under Charter section 280(a)(1), this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that, after full discussion and deliberation by the Council, Councilmember Marti Emerald is hereby selected as Council President to serve a one-year term commencing on December 7, 2015, and until a successor is selected and qualified.


