DATE OF FINAL PASSAGE DEC 16 2015

A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AUTHORIZING THE ADVERTISEMENT AND  
EXECUTION OF TWO CONTRACTS FOR SLURRY SEAL  
GROUPS 1601 AND 1602.

WHEREAS, the Slurry Seal Groups 1601 and 1602 are part of the City's Street  
Resurfacing Program for Fiscal Year 2016; and

WHEREAS, in Fiscal Year 2016, the Resurfacing Program plans to slurry seal 210 miles  
of streets; and

WHEREAS, these contracts will provide for the repair and slurry sealing of  
approximately 70 to 80 miles of various asphalt streets located throughout the City; and

WHEREAS, locations for the Resurfacing Program are chosen through the use of the  
following criteria: Overall Condition Index (OCI), maintenance history, functional classification,  
proximity to emergency facility/tourist attraction, community input, and Mayor/Council input;  
and

WHEREAS, funds are available for the contracts from the Gas Tax Fund and Proposition  
42 Replacement Fund in Transportation and Storm Water Department's budget; NOW,  
THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his  
designee, is authorized to advertise and execute a construction contract for Slurry Seal Group  
1601 and a construction contract for Slurry Seal Group 1602, each with the lowest responsible  
and reliable bidder contingent upon the Chief Financial Officer first furnishing one or more

certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that Chief Financial Officer is authorized to expend funds in an amount not to exceed \$4,500,000 from Fund 200306, Prop 42 Replacement fund and \$4,607,454 from Fund 200218, Gas Tax Fund, Transportation & Storm Water Department – Street Division, for the purpose of funding the Slurry Seal 1601 and Slurry Seal 1602 construction contracts, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that the funds necessary for expenditure under the established contract funding phases are, or will be, on deposit with the City Treasurer.
