WHEREAS, the City and Local 127 have reached an agreement that it is in the best interest of all parties to amend the 2009 Plan to include the City's proposed discretionary amendments contained in the proposed amended and restated plan; and

WHEREAS, this San Diego City Council (Council) action is to approve an Agreement that memorializes the agreement between the City and the Local 127 (Agreement); and

WHEREAS, under the Meyers-Milias-Brown Act (MMBA), the State law related to collective bargaining between the City and its represented employees, and Council Policy 300-06, it is within the discretion of the Council to approve and ratify the negotiated agreement; and

WHEREAS, the Council desires to approve and ratify the accompanying "Agreement between the City of San Diego and American Federation of State, County and Municipal Employees, Local 127 Related to Amendments to the City of San Diego 401(a) Plan"; NOW, THEREFORE,
