A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE RELEASE OF NINE MONUMENT BONDS ASSOCIATED WITH VARIOUS SUBDIVISION MAPS LOCATED THROUGHOUT THE CITY OF SAN DIEGO PURSUANT TO SECTION 66497 OF THE GOVERNMENT CODE.

WHEREAS, there is a request to approve the release of nine monument bonds associated with the setting of property monument markers for projects previously approved by the City of San Diego (City) through final and parcel maps; and

WHEREAS, monuments are used for marking property boundaries and rights-of-way, and typically consist of a lead plug set in the sidewalk, top of curb, or any other solid semi-permanent medium with a 3/4" brass disc; and

WHEREAS, when a subdivision map is approved by the City, the subdivider has the option to delay the setting of the property corners (monuments) until the improvements associated with the subdivision are completed; and

WHEREAS, in order to delay the setting of these monuments, the subdivider is required to post a cash bond with the City to cover the cost of setting the survey monuments at a later date; and

WHEREAS, Government Code section 66497 of the Subdivision Map Act (SMA) governs how these monument bonds are to be released; and

WHEREAS, these monument bonds will normally be released back to the subdivider if the monument bonds have been set to the satisfaction of the City Engineer, and the land surveyor or engineer of record has been paid; and WHEREAS, the cash bonds received by the city are held in a non-interest bearing account until the interested party request their release. City staff then processes the requests and confirms the circumstances and release of the bonds; and

WHEREAS, under Charter section 280(a)(1), this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the monuments for the following maps have been set to the satisfaction of the City Engineer and payment of the land surveyor or engineer has been confirmed. The City Council authorizes the release of the bonds pursuant to section 66497 of the SMA to the associated depositors listed below:
