A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AMENDING COUNCIL POLICY 900-17
ENTITLED "STOREFRONT IMPROVEMENT PROGRAM."

WHEREAS, the City of San Diego (City) started the Storefront Improvement Program (SIP) in 1986 to provide incentives to small business and property owners to improve their storefronts consistent with design standards for their commercial areas; and

WHEREAS, in 2001, the Council of the City of San Diego (Council) adopted Resolution No. R-295442, establishing Council Policy 900-17 which sets forth guidelines and procedures regarding the SIP application process, selection process, design process, incentive awarding, and fees associated with the SIP; and

WHEREAS, in 2009, the Council adopted Resolution No. R-304702, amending Council Policy 900-17; and

WHEREAS, the Council now desires to further amend Council Policy 900-17 to increase eligibility threshold, refine ineligible categories, eliminate the public art incentive category, and create a new permitting costs incentive category; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that:


