WHEREAS, in 2009, the Council adopted Resolution No. R-304702, amending Council Policy 900-17; and

WHEREAS, the Council now desires to further amend Council Policy 900-17 to increase eligibility threshold, refine ineligible categories, eliminate the public art incentive category, and create a new permitting costs incentive category; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council of the City of San Diego finds that the modifications to Council Policy 900-17 approved pursuant to Resolution Number R-310126 are not subject to the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines sections 15060(c)(3) and 15378 because this activity will not result in direct or indirect physical changes in the environment.
