A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$10,000 TO THE UNION OF PAN ASIAN COMMUNITIES FOR THE HIGH-RISK ASIAN/PACIFIC ISLANDER MENTORSHIP PROGRAM, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the Union of Pan Asian Communities has requested funding for the High-Risk Asian/Pacific Islander Mentorship Program; and

WHEREAS, the requested funding will be used for salaries and benefits, office supplies, and money for field trips in support of UPAC's year-around Mentorship program, which serves approximately 100 youths at Challenger Middle and Mira Mesa High High Schools in Mira Mesa; and

WHEREAS, UPAC's request for funding for the High-Risk Asian/Pacific Islander Mentorship Program benefits the City economically, socially, and culturally: 1) with high school drop outs making an estimated 65% less than high school graduates, the economic value of a high school education is significant; 2) a reduction in gang involvement and crime improves the safety and quality of life for all residents, most specifically those living in high crime

neighborhoods; and 3) the City benefits from its diverse cultures when minority populations are not marginalized; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 6 recommends an allocation of \$10,000 to the Union of Pan Asian Communities for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 8, which provides: "Community Projects, Programs and Services funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2015 City Council Allocations Agreement between the City of San Diego and the Union of Pan Asian Communities (Agreement) in an amount not to exceed \$10,000 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-310137.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$10,000 from the Community Projects, Programs, and Services budget Fund No. 100000, Cost Center 1106110006, to provide funds for the above-referenced

Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
