A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ADOPTING THE CITY OF SAN DIEGO CITY CLERK ADMINISTRATIVE GUIDELINES RELATED TO MUNICIPAL ELECTIONS

WHEREAS, the City Clerk serves as the election official for the City of San Diego; and

WHEREAS, the City of San Diego City Clerk Administrative Guidelines (the Guidelines) are referenced in the San Diego Municipal Code and include requirements applicable to municipal political candidates' designations of title on ballot materials, and to the form and formatting requirements for referendum, initiative, and recall petitions; and

WHEREAS, certain form and formatting requirements previously referenced in the San Diego Municipal Code now state that they are detailed in the Guidelines, providing the City Clerk's Office with an easier way to keep the requirements updated and to reflect best practices; and

WHEREAS, the Guidelines, once approved, would be brought back to the City Council periodically for review and approval if amendments are proposed; and

WHEREAS, the Guidelines currently include a section titled "Designation of Principal Profession or Occupation" for candidates, and a section titled "Recall Petitions," providing guidelines related to the recall process; and

WHEREAS, the City Clerk now seeks to add a section titled "Referendum Petitions," and a section titled "Initiative Petitions"; and

WHEREAS, the Guidelines will be available to the public at the Office of the City Clerk and also will be published on the City Clerk's website at www.sandiego.gov/city-clerk; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City of San Diego City Clerk Administrative Guidelines are hereby adopted, with a copy as adopted to be placed on file in the Office of the City Clerk as Document No. RR- 310146 and also published on the City Clerk's website.
