A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ESTABLISHING A TEMPORARY RULE AMENDING RULES 6.10.1, 6.10.5, AND 6.10.7, RELATING TO STANDING COMMITTEE COMPOSITION AND RESPONSIBILITIES.

WHEREAS, Rule 9 of the Permanent Rules of the Council provides that the Council President may, at any time, place on the Adoption Agenda a resolution establishing a temporary rule that, for the time being, has the effect of a standing rule; and

WHEREAS, Rule 9 further provides that if the temporary rule conflicts with a permanent rule, it shall supersede the permanent rule for such time as may be specified in the temporary rule; and

WHEREAS, it has been proposed that San Diego Municipal Code (Municipal Code) section 22.0101 (Rules of Council) be amended to reestablish the City Council Committee on Rules and that the membership of the Committee on Economic Development and Intergovernmental Relations and the Committee on Budget and Government Efficiency be reduced from five members to four; and

WHEREAS, an ordinance to amend the Rules of Council, including Rule 6.10.7 reestablishing the Committee on Rules and Rules 6.10.1 and 6.10.5, reducing from five to four the members of the Committee on Economic Development and Intergovernmental Relations and the Committee on Budget and Government Efficiency, respectively, is in the process of legislative enactment; and

WHEREAS, these Rules of Council will not take effect until the second reading is completed in January and 30 days have passed; and

WHEREAS, it is necessary to provide, pursuant to Rule 9, a temporary rule to provide for reestablishment of the Committee of Rules and to address the membership of the Committee on Economic Development and Intergovernmental Relations and the Committee on Budget and Government Efficiency, until such time as the ordinance amending Rules 6.10.1(a), 6.10.5(a), and 6.10.7, is effective or rejected; and

WHEREAS, the temporary rule will contain the same language as the ordinance, thereby permitting appropriate appointments to each of the three committees in a timely manner; and

WHEREAS, under Charter section 280(a)(1), this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the City Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council approves the establishment of Temporary Rules 6.10.1(a), 6.10.5(a), and 6.10.7 providing for membership on the Committee on Economic Development and Intergovernmental Relations and the Committee on Budget and Government Efficiency and reinstating the Committee on Rules, pursuant to San Diego Municipal Code section 22.0101, Rule 9, entitled "Temporary Rules," to read as follows:

6.10.1 Committee on Economic Development and Intergovernmental Relations

(a) The Committee on Economic Development and Intergovernmental Relations shall be composed of four voting councilmembers.

6.10.5 Committee on Budget and Government Efficiency

(a) The Committee on Budget and Government Efficiency shall be composed of four voting councilmembers.

6.10.7 Committee on Rules

- (a) The Committee on Rules shall be composed of five voting Councilmembers. The Council President shall serve as chair and the Council President Pro Tem shall serve as vice chair.
- (b) The Committee shall have the following areas of responsibility: Rules of Council, City Charter, Open Government, Elections and Ballot Measures, Annexations, Boards and Commissions, Communications, Customer Service, Public Outreach, Council-initiated matters as provided in Rule 7.1, and Committee Composition and Responsibilities.

BE IT FURTHER RESOLVED, that pursuant to Rule 9, such Temporary Rules 6.10.1(a), 6.10.5(a) and 6.10.7 shall be in full force and effect until the proposed ordinance amending Rules 6.10.1(a), 6.10.5(a) and 6.10.7 is passed or rejected by the City Council.
