A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO ESTABLISHING A TEMPORARY RULE  
AMENDING RULE 2.2, RELATING TO COUNCIL ORDER OF  
BUSINESS FOR CLOSED SESSION.

WHEREAS, Rule 9 of the Permanent Rules of the Council provides that the Council President may, at any time, place on the Adoption Agenda a resolution establishing a temporary rule that, for the time being, has the effect of a standing rule; and

WHEREAS, Rule 9 further provides that if the temporary rule conflicts with a permanent rule, it shall supersede the permanent rule for such time as may be specified in the temporary rule; and

WHEREAS, it has been proposed that San Diego Municipal Code (Municipal Code) section 22.0101 (Rules of Council) be amended to provide for the following changes in the order of business for the Tuesday City Council meeting: closed session public comment to occur immediately prior to closed session at 9:00 a.m.; consent agenda to be heard immediately following the pledge of allegiance; and items pulled from consent to be heard after presentation of proclamations and before non-agenda public comment; and

WHEREAS, an ordinance to amend the Rules of Council, including Rule 2.2 to allow for the above stated changes in the order of business is in the process of legislative enactment; and

WHEREAS, these Rules of Council will not take effect until the second reading is completed in January and 30 days have passed; and

WHEREAS, the City Council desires to adopt a temporary rule to allow for closed session public comment on Tuesdays at 9:00 a.m. and to allow for consent items to be earlier in the agenda as indicated above to provide for more efficient use of staff time; and

WHEREAS, under San Diego Charter section 280(a)(1), this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the City Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Council approves the establishment of a Temporary Rule 2.2 providing for closed session public comment to occur on Tuesdays at 9:00 a.m., immediately prior to convening into closed session and for reordering of the agenda to allow consent items to be heard earlier, providing for more efficient use of staff time, to read as follows:

**2.2 Order of Business**


