WHEREAS, this is for a five (5) year agreement with Dudek to support the Public Utilities Department (Department) for a maximum compensation amount not to exceed \$5,000,000; and

WHEREAS, these environmental services are generally provided in-house it is occasionally necessary to utilize as-needed environmental services; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor, or his designee, is hereby authorized to execute an agreement with Dudek to provide As-Needed Environmental Services, for a minimum of \$1,000 and total amount not to exceed \$5,000,000, with a contract duration of five (5) years.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$5,000,000 in total from the following four Sewer Funds: 700000 (Muni Sewer Revenue), 700001 (Metro Sewer Utility), 700008 (Muni Sewer CIP), 700009 (Metro Sewer CIP); and from the following two Water Funds, 700011 (Water Operating) and 700010 (Water Utility CIP), for the purpose of funding the As-Needed Engineering Consultant Services Agreement, contingent upon adoption of the Annual Appropriation Ordinance for the applicable fiscal year, and contingent upon the City Comptroller furnishing one or more
