A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE CITY OF SAN DIEGO'S GRANT APPLICATION AND ACCEPTÂNCE OF FUNDING FROM THE COUNTY OF SAN DIEGO'S NEIGHBORHOOD REINVESTMENT PROGRAM.

WHEREAS, the City seeks to apply for a grant in an amount not to exceed \$20,000 from the County of San Diego's (County) Neighborhood Reinvestment Program, a copy of which is included as an attachment to the staff report dated November 13, 2015 (Staff Report); and

WHEREAS, the Neighborhood Reinvestment Program provides grant funds to County departments, public agencies, and non-profit community organizations for one-time community, social, environmental, educational, cultural, or recreational needs; and

WHEREAS, public agencies may apply to fund programs and projects that benefit the community and enhance the region's quality of life; and

WHEREAS, the City will expend the grant funds of up to \$20,000 on a one-time study that analyzes the economic benefits created by the film industry, including increased local jobs and tourism (Film Industry Economic Impact Study); NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The Council authorizes the Mayor, or designee, to file a grant application with the County, to execute any necessary grant agreement, and to take all other necessary actions to secure an amount not to exceed \$20,000 in Neighborhood Reinvestment Program Grant funds.
