AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AMENDMENTS TO THE CITY'S CLASS I AND CLASS II NON-EXCLUSIVE SOLID WASTE COLLECTION FRANCHISE AGREEMENTS.

WHEREAS, by ordinance, the City Council granted solid waste collection franchises to, and authorized execution of franchise agreements with, the Class I and Class II franchisees listed on the attached Exhibit A; and

WHEREAS, the franchise agreements, as subsequently amended by ordinances adopted by the City Council, currently provide for a seven-year term with an option for annual, one-year extensions, subject to City Council approval by ordinance; and

WHEREAS, the proposed amendments provide for an eight-year term, and establish franchisee requirements related to organic waste recycling under Assembly Bill 1826 and minimum annual diversion rates, under the terms and conditions set forth in the proposed franchise amendments; and

WHEREAS, City staff have met with the franchisees regarding the proposed franchise amendments; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is authorized to execute, for and on behalf of the City, Eighth Amendments to the Class I Non-Exclusive Franchise Agreements for Solid Waste Management Services with the Class I franchisees listed on the attached Exhibit A (except for Daily Disposal Services, Inc.), under the terms and conditions set forth in the Eighth Amendment on file in the Office of the City Clerk as Document No. OO-20600-3
