AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE CITY'S PARTICIPATION IN THE WATER CONSERVATION GARDEN'S JOINT POWER OF AUTHORITY BY AMENDING THE ORIGINAL 2003 AGREEMENT AND TO AUTHORIZE PAYMENT AND CONTINUED PARTICIPATION THROUGH FISCAL YEAR 2026.

WHEREAS, the City of San Diego (City) joined the Water Conservation Garden Joint Powers of Authority (JPA) in 2003, the only demonstration garden in the region that had a full educational component on water efficient landscaping and irrigation, specifically on landscape design, plant selection, use of mulch and various grass types, composting, native plants, fire-wise landscaping, maintenance and irrigation components; and

WHEREAS, it is beneficial for the City and the Public Utilities Department to offer this location to its customers as part of enhanced customer service and education, thus the City moved to join the JPA in 2003 in order to formally support the facility; and

WHEREAS, the Public Utilities Department is first re-routing the original agreement with a blank signature page to obtain authorization to join the JPA and the proper required signatures, is seeking validation of yearly dues paid since 2003, and is seeking approval to continue its participation in the First Amendment to the JPA from FY2016 through FY2017 in an amount not to exceed \$78,097 per year, and authorization to pay dues not to exceed \$80,000 during the period FY2018 through FY2026; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is authorized to validate the City's participation in the Water Conservation Garden's Joint Powers of Authority (JPA) by amending the signature page of the original 2003 agreement to reflect the appropriate signature authority.

Section 2. That the retroactive validation and authorization of payment of the City's annual dues from Public Utilities 700011 Water Utility Operating Fund, Cost Center #2000141301, and General Ledger #512172, is authorized from the date of the original 2003 Agreement through Fiscal Year 2015.

Section 3. That the Mayor, or his designee, is authorized to execute the First Amendment to the Agreement with the JPA for the continued participation in the Water Conservation Garden JPA for Fiscal Years 2016 and 2017, using the same accounting numbers, in an amount not to exceed \$78,097 annually.

Section 4. That the Chief Financial Officer is authorized to expend an amount not to exceed \$78,097 from Public Utilities 700011 Water Utility Operating Fund, Cost Center #2000141301, and General Ledger #512172, for the purpose of funding this First Amendment to the Agreement for Fiscal Years 2016 and 2017, contingent upon the Chief Financial Officer furnishing a certificate certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

Section 5. That the City's continued participation in the Water Conservation Garden JPA through the First Amendment is authorized for Fiscal Years 2018 through 2026, using the same accounting numbers, in an amount not to exceed \$80,000 annually.

Section 6. That the Chief Financial Officer is authorized to expend an amount not to exceed \$80,000 from Public Utilities 700011 Water Utility Operating Fund, Cost Center

#2000141301, and General Ledger #512172, for the purpose of funding this First Amendment

from FY2018 through FY2026, contingent upon the Chief Financial Officer furnishing a

certificate certifying that funds necessary for expenditure are, or will be, on deposit with the City

Treasurer.

Section 7. That the Chief Financial Officer, upon advice from the administering

department, is authorized to transfer excess funds, if any, to the appropriate reserves.

Section 8. That a full reading of this ordinance is dispensed with prior to its passage, a

written or printed copy having been made available to the City Council and the public prior to

the day of its passage.

Section 9. That this ordinance shall take effect and be in force on the thirtieth day from

and after its final passage.
