ORDINANCE NUMBER O- 20659 (NEW SERIES)

DATE OF FINAL PASSAGE JUN 22 2016

AN ORDINANCE AMENDING CHAPTER 8, ARTICLE 6, DIVISION 1 OF THE MUNICIPAL CODE BY AMENDING SECTION 86.0107 RELATING TO TOW-AWAY ZONES.

WHEREAS, San Diego Municipal Code section 86.0107 authorizes the City Council to establish tow-away parking zones between the hours of 7 a.m. to 7 p.m.; and

WHEREAS, the “No Park 5th/Active Loading Zone” Pilot Project seeks to remove parked vehicles along 5th Avenue between Broadway and Harbor Drive on Friday and Saturday nights to ease the flow of pedestrian traffic and improve public safety; and

WHEREAS, in order for the Project to be successful, City staff has determined that parking along that section of 5th Avenue should be converted to a tow-away zone during the hours of 8 p.m. to 3 a.m.; and

WHEREAS, it is necessary to amend SDMC section 86.0107 to create this tow-away zone for the Project; NOW THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That Chapter 8, Article 6, Division 1, section 86.0107 of the San Diego Municipal Code is amended to read as follows:


§86.0107 Tow-Away Zones

The City Council may by resolution prohibit the parking or standing of vehicles on any street or portion thereof between the hours of 7:00 a.m. and 3:00 a.m. and authorize the removal of any vehicles so parked or standing from such street under or pursuant to Section 82.30.

Section 2. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its final passage.




