AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR TO EXECUTE AMENDMENTS EXTENDING THE CONTRACTS WITH A TO Z TOWING ENTERPRISES, INC. DBA ROADONE; ALLIED GARDENS TOWING, INC. DBA ROADONE; C&D TOWING SPECIALISTS, INC.; ALEXANDRA INVESTMENT INC., DBA ANGELO'S TOWING; GUARDIAN TOWING, INC.; AMERICAN TOWING, INC.; AND CORTES TOWING ENTERPRISES, INC., FOR POLICE-INITIATED VEHICLE TOWING AND IMPOUND SERVICES.

WHEREAS, in 2010 the City of San Diego issued a Request for Qualification seeking qualified Licensed Tow Providers (LTPs) and Licensed Impound Providers (LIPs) to furnish the City with vehicle towing and impound; and

WHEREAS, thirteen contractors qualified to provide towing services or impound services, or both; and

WHEREAS, the City entered into contracts with the thirteen qualified contractors for a term not to exceed five years; and

WHEREAS, eight contractors currently remain under contract with the City; and WHEREAS, two contractors are LTPs and LIPs, providing both towing services and impounded services; and

WHEREAS, six contractors are LTPs, providing only towing services; and

WHEREAS, the contracts are cost-neutral because the cost of services is paid for by registered owners whose vehicles are towed and impounded, and who pay the tow and storage fees upon redeeming their vehicles from impound; and

WHEREAS, the LTP and LIP contracts will begin to expire in August 2016; and

WHEREAS, the Police Department requests to extend seven LTP contracts and two LIP contracts beyond five years so that a new solicitation for towing and impound services can be prepared; and

WHEREAS, there is no cost to the City associated with this contract extension; and WHEREAS, under San Diego Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by ordinance adopted by a two-thirds' majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is authorized to execute for and on behalf of the City a Third Amendment to the contract with A to Z Towing Enterprises, Inc., doing business as RoadOne, for Licensed Impound Provider services in tow zones 2b, 3, 4, 5, and 8, extending the existing five-year agreement for one year, through August 1, 2017.

Section 2. That the Mayor or his designee is authorized to execute for and on behalf of the City a Third Amendment to the contract with Allied Gardens Towing, Inc., doing business as RoadOne, for Licensed Impound Provider services in tow zones 1, 2a, 6, and 7, extending the existing five-year agreement for one year, through August 1, 2017.

Section 3. That the Mayor or his designee is authorized to execute for and on behalf of the City a Fourth Amendment to the contract with A to Z Towing Enterprises, Inc., doing business as RoadOne, for Licensed Tow Provider services in tow zones 1, 2, 3, 4, 5, 6, 7, and 8, extending the existing five-year agreement for one year, through August 1, 2017.

Section 4. That the Mayor or his designee is authorized to execute for and on behalf of the City a Fourth Amendment to the contract with Allied Gardens Towing, Inc., doing business as RoadOne, for Licensed Tow Provider services in tow zones 1, 2, 3, 4, 5, 6, 7, and 8, extending the existing five-year agreement for one year, through August 1, 2017.

Section 5. That the Mayor or his designee is authorized to execute for and on behalf of the City a Fourth Amendment to the contract with C&D Towing Specialists, Inc., for Licensed Tow Provider services in tow zones 2, 4, 5, 6, and 7, extending the existing five-year agreement for one year, through August 1, 2017.

Section 6. That the Mayor or his designee is authorized to execute for and on behalf of the City a Fourth Amendment to the contract with Alexandra Investment, Inc., doing business as Angelo's Towing, for Licensed Tow Provider services in tow zones 3, 4, 5, 6, and 7, extending the existing five-year agreement for one year, through August 1, 2017.

Section 7. That the Mayor or his designee is authorized to execute for and on behalf of the City a Fourth Amendment to the contract with Guardian Towing, Inc., for Licensed Tow Provider services in tow zone 1, extending the existing five-year agreement for one year, through August 1, 2017.

Section 8. That the Mayor or his designee is authorized to execute for and on behalf of the City a Fourth Amendment to the contract with American Towing, Inc., for Licensed Tow Provider services in tow zone 8, extending the existing five-year agreement for one year, through August 1, 2017.

Section 9. That the Mayor or his designee is authorized to execute for and on behalf of the City a Fourth Amendment to the contract with Cortes Towing Enterprises, Inc., for Licensed Tow Provider services in tow zone 8, extending the existing five-year agreement for one year, through August 1, 2017.

Section 10. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the City Council and the public prior to the day of its passage.

Section 11. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
